Baden in Germany on or about the 6 day of January 1869; that I emigrated to the United States, sailing on board the Stamm Torpedo from Leipzig on or about the \_\_\_\_\_ day of July 1889; that I resided 8 years, uninterruptedly, in the United States, from 1889 to 1897 at Grand Rapids, Mich. that I was naturalized as a citizen of the United States before the Southern Court of Grand Traverse County at Traverse City, Mich. on the 21 day of April 1897 as shown by the accompanying Certificate of Naturalization; that I am the IDENTICAL PERSON described in said Certificate; that I am domiciled in the United States, my permanent residence being at Southern Leelanau County in the State of Michigan where I follow the occupation of Priest; that I am about to go abroad temporarily; and that I intend to return to the United States within six months with the purpose of residing and performing the duties of citizenship therein.
